The number of words should not exceed a maximum of 300 words using justified format.

## 1 INTRODUCTION

This document provides details of the scope of the journal, the review process, criteria for assessment and acceptance of the paper as well as expectation of how the journal should look like. It specifies how materials presented for submission to IJMCS should look like in terms of the Fonts, Formatting, Styles, Numbering and structures of the paper.

## 2 SCOPE OF THE JOURNAL

International Journal of Mathematics, Statistics and Computer Science is dedicated to publish original articles in **ALL** areas of **MATHEMATICS, STATISTICS** and **COMPUTER SCIENCE**. It will provide a forum for young and upcoming researchers to publish their original work with ease. We will assist researchers on intricacies of research writing and provide avenue where their original work can compete favorably among comity of researchers within their chosen domain. To achieve this, the review process is designed in a way to help researchers in areas of research development, research writing and publications to meet international standard. In IJMCS, the expected number of pages should not exceed ten (10) as additional pages attracts additional charges.

## 3 REVIEW PROCESS

IJMCS wish to make review process comprehensive but simple enough for the author as long as the content has merit in a learned community. The review process will be broad to accommodate

### 3.1 Stages of Review

- i. Submission of original article via [submission\\_ijmscs@worldmerit.com.ng](mailto:submission_ijmscs@worldmerit.com.ng) by using our template which can be downloaded at [www.worldmerit.com.ng/IJMCS-Template](http://www.worldmerit.com.ng/IJMCS-Template)
- ii. Acknowledgment of submission within 48 hours
- iii. Editorial Board appraisal and recommendation for review
- iv. Appointment of 2 to 4 reviewers
- v. Report of reviewers collected
- vi. The score sheet of the reviewer determines the status of the paper after review
- vii. Communicate the author on the outcome of review
- viii. Payment of processing fees if accepted
- ix. Forward the Gallery Proof to author for final check of the paper
- x. Online publication

### 3.2 Criteria for Assessment of Submission

To get the best quality for our submission, the reviewer grades the submission based on

- i. Originality
- ii. Use of language
- iii. Title
- iv. Abstract
- v. Conclusion
- vi. Data presentation and analysis
- vii. References and citation
- viii. Presentation of facts
- ix. Formatting
- x. Figures, tables and charts

Each of these items attracts 10points totaling 100. Where a submission doesn't have any of these items (i.e., item vi or x), the submission will be assessed based on the total number of items available in the submission. The decision for publication from the number of reviewers will be average of the total number of scores received at the time of the decision.

## 4 STRUCTURE OF THE JOURNAL ARTICLE

Authors have preferences as to the sections to be used for the paper. In general, some are numbered while some are not. These sections include

- i. Title
- ii. Authors Name and affiliations
- iii. Abstract
- iv. Keywords
- v. Acknowledgement
- vi. Introduction
- vii. Description of the problem/ Background
- viii. Main result
- ix. Results
- x. Discussion
- xi. Conclusion and references

The items i-v are sections that are not numbered while the sections vi-xi are numbered. The choice of vi-xi is left for the author depending on the level of information in the paper but must sufficiently reflect the basic aspect of research writing.

## 5 FORMATTING

In this section we provide information on fonts, styles and other section formatting

### 5.1 Page Setup and Fonts

Top, bottom, left, and right margins should be 1 inch. Use Calibri throughout the manuscript, in the sizes and styles shown in Table 1.

## 5.2 Footnotes

Footnotes should be used only when necessary to present important documentary or explanatory material whose inclusion in the text would be distracting<sup>1</sup>.

## 5.3 Acknowledgement

The details of acknowledgement should be given in the box provided on page 1 of the work

## 5.4 Code, Data, and Materials Availability

Availability of codes, data, and/or materials used in the research results reported in the manuscript may be declared either within the text, the appendix or a link for such additional materials. This may be given under a separate heading stating rules and conditions of use as well as reasons why the section is treated as such. This must be made available during review process if need be.

## 6 EQUATIONS, FIGURES AND TABLES

### 6.1 Equations

Equations in journal publication varies from simple mathematical expression to a more complex expression. Author should utilize software that will not interfere with the structure of the work. A simple Equation Editor in Microsoft Word is enough for most authors while MathType© is sufficiently useful for all classes of equations as well as equation numbering and formatting. A simple non emphatic expression can be inputted within text i.e.,  $A = \sin bx$  using "Inline" on the "Insert Equation" of the Equation Editor. A more complex or more emphasis, use " Display" i.e.

$$x = \frac{-b \pm \sqrt{b^2 - 4ac}}{2a}$$

And where the equation requires to be referenced later in the text," Right numbered" is preferred with numbering starting from 1 i.e.

$$x = \frac{-b \pm \sqrt{b^2 - 4ac}}{2a} \quad (1)$$

### 6.2 Figures

Figures are numbered in the order in which they are called out in the text. Figures should be embedded in the manuscript. Authors should guide against use of application files (e.g., Corel Draw, Microsoft PowerPoint, etc.). All figure parts must be labeled (a), (b), etc. Appropriate caption should be given to all figures used at the bottom of the figure. In order to allow figure to stand alone use picture formatting "Top and Bottom" in the Picture Layout

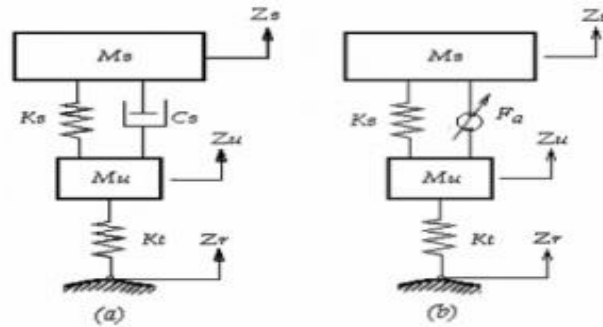


Figure 1: Passive and active quarter car model

### 8.1 Endnotes, Mendeley or other citation manager

These software are specifically useful to organize citation and references. Aside other usefulness it allows author to concentrate on the major work while citation and references are done automatically. The importance of this section supersedes the ability to write since issue of plagiarism is still a serious matter.

### 8.2 References

IJMCS uses Numbering Style for citation and Referencing. In this style, the order of appearance of author in the citation is also the same in reference. For example, with EndNote© X7, the citation **[1]** is for **Journal citation**, **[2]** for **conferences proceeding** and **[3]** for **books**. **Article or chapter in an a report [4]** , **Article or Chapter in Edited book**, **[5]**, **article from online magazine [6]** and **thesis [7]**.
